NOTICE TO EXHIBITORS

Please read the following carefully. If you have any questions, please give us a call.

SELECTION OF BOOTH CATEGORY:

There are 4 specific categories for booth space...3 for CRAFTERS/ARTISTS, and 1 for RETAILERS/WHOLESALERS. To qualify as a CRAFTER/ARTIST, your wares MUST BE MADE BY YOU! NOTHING in your booth can be manufactured or purchased from another source other than the materials needed in the preparation of your craft/art. Additionally, if you sell to retailers/wholesalers, or if you are featured in any catalogs, you are eliminated as a crafter/artist and will be classified as a RETAILER.

Once you have determined that you qualify as a CRAFTER/ARTIST, and you select the appropriate category, no item in your booth may exceed the top price within that category. For example, if 99% of your wares are priced at \$10.00 or under and you have 1% that is over \$10.00, the highest priced item would prevail and you would have to move to the next category.

PRODUCTS TO BE FEATURED:

Leisure Time Unlimited, Inc. does not guarantee exclusivity to any Exhibitor for products and/or services displayed at this show. In order to minimize duplications, please state exactly what you plan to exhibit and if the product has a brand name, that name must be shown as well.

COSTUMES:

Once again, we want to emphasize that the MANDATORY 19TH CENTURY COSTUME REQUIREMENT APPLIES TO EVERYONE...husbands, wives, cousins, aunts, uncles, helpers...EVERYONE! NO ONE wearing an Exhibitor Badge will be admitted unless they are wearing the appropriate costume! (This also applies to "last minute" helpers...relief help...ANYONE.) IF YOU ARE WORKING IN A BOOTH, YOU MUST BE IN COSTUME...NO EXCEPTIONS! Anyone who is not properly costumed will be asked to leave the booth.

Please note Item #10 on the Terms And Conditions portion of our contract stating that each exhibitor MUST wear costumes for the show. If anyone is not in compliance, please be advised that the exhibitor will NOT be allowed to participate in the show again without a \$200 costume compliance deposit. At the close of that show, \$50 per day will be returned for those adhering to the rules.

We plan to continue our efforts to heighten the appeal of the show by adding some new enhancement each year. We promote our show as an authentic DICKENS CHRISTMAS SHOW...we'll do our part by providing a true DICKENS venue...now you must do yours! WEAR YOUR COSTUMES!
